

PREPARATION

Before beginning assembly of product, make sure all parts are present. Compare parts with package contents list and diagram above. If any part is missing or damaged, do not attempt to assemble, install or operate the product. Contact customer service for replacement parts.

- Estimated Assembly Time: 5 minutes
- No tools required for assembly.

ASSEMBLY INSTRUCTIONS

1. Connect the two extension tubes (A) with the coupler (B). Fig. 1

NOTE: Use the coupler (B) if no spitters are to be used.



2. Connect the extension tubes (A) to the diverter valve (J). Make sure the arrow on the valve is positioned as shown and the diverter valve is connected as shown. Fig. 2

NOTE 1: Use diverter valve (J) to simultaneously run a spitter and fountain head from one pump.



3. For 1/2 in. tubing, connect the tubing onto the second output of the diverter valve. Connect the other end of the tubing to a spitter or other water feature. Fig. 3

NOTE: Tubing and spitter are NOT INCLUDED.



4. Connect the fountain head to the top extension tube. Adjust the diverter valve to split the flow between the fountain head and the spitter. Fig. 4



5. Choose a fountain head for the desired water effect, and assemble your choice as shown in Fig. 5




6. For the PF350, PP225, PP350, PP575, use the 3/4" adapter to connect the pump to the extension tubes. Fig. 6



7. For the PF500, use the 5/8" adapter to connect the fountain head kit onto the pump. Fig. 7

NOTE: 5/8" adapter is NOT INCLUDED.




CARE AND MAINTENANCE

- Periodically disassemble the fountain head kit and clean the parts.
- Use a cloth or soft brush with warm, soapy water. Be sure to use biodegradable soap.

LIMITED WARRANTY

All pumps and electrical products are warranted to the user against defective material and workmanship, under normal working conditions. This warranty period begins on the date of purchase by the original purchaser.

Unless otherwise specified all pond boss® electrical products are warranted to the user against defective material and workmanship, under normal working conditions for <u>1 year</u> from the date of purchase.

- Pond and Waterfall pumps are warranted for 3 years.
- <u>All pond boss® liners</u> are warranted to the user against defective workmanship, under normal working conditions for 20 years from the date of purchase.
- All other pond boss® products are warranted to the user against defective material and workmanship, under normal working conditions for 90 days.

Application

Warranty covers only properly installed and maintained units. Any damage to the cord or modification to the unit will invalidate the warranty. Pump warranty is limited to applications pumping fresh water in a pond or fountain only. Other liquid applications or extreme temperature uses must be approved in writing by the manufacturer. Receipt and product date code are required for warranty claims.

Warranty Claim

<u>Warranty claims must be made by calling customer service (at 1-888-755-6750).</u> If the item is determined to be defective, you will be given authorization to return the defective part(s), <u>freight pre-paid</u>, along with <u>proof of purchase</u>.

Disposition

The manufacturer will make a good faith effort for prompt disposition regarding all warranty claims. Returned product will be inspected to determine cause of failure before warranty is applied. Warranty does not cover any costs associated with the shipping, handling, installation or removal of products or parts subject to this warranty. For products damaged in transit, a claim should be filed with the carrier.

Disclaimer

Any oral statements made about the product by the seller, the manufacturer, the representatives, or any other parties do not constitute warranties, should not be relied upon by the user, and are not part of the contract for sale. The seller's and manufacturer's only obligation, and buyer's only remedy shall be for the manufacturer to either replace and/or repair at the manufacturer's sole discretion, the product as described above.
