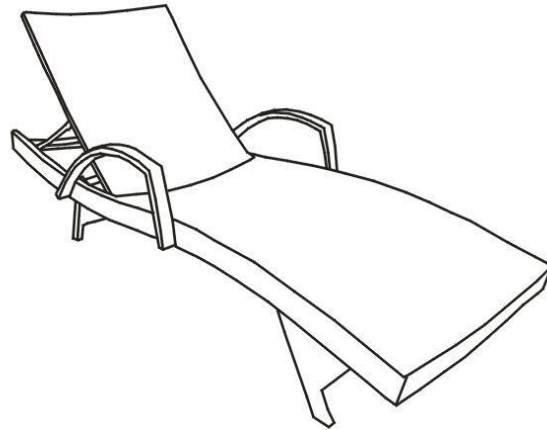


# Assembly Instructions

## Chaise Lounge



### Parts List

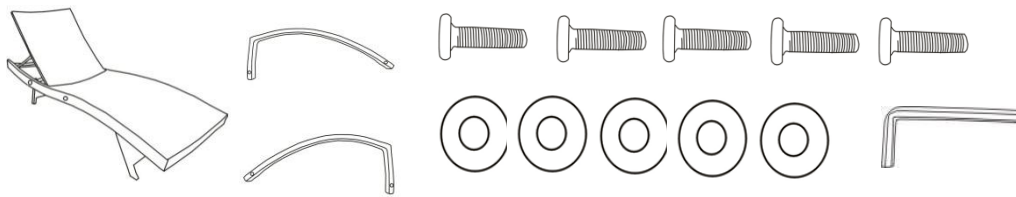
Label	Picture	Description	QTY
A	A line drawing of the main base of the chaise longue, showing the reclining mechanism and the flat seat surface.	Chaise Longue Base	1
B	A line drawing of a curved armrest component.	Left Arm	1
C	A line drawing of a curved armrest component, similar to the left arm but mirrored.	Right Arm	1

①	A line drawing of an L-shaped Allen key.	Allen Key	1
②	A line drawing of a bolt with a hexagonal head and a threaded shaft.	Bolt (M8*40MM)	5

# Assembly Preparation

Before Beginning Assembly:



- Read instructions, cover to cover-



- Have 2 adults on hand for assembly-



- Do not assemble on flooring or carpet-



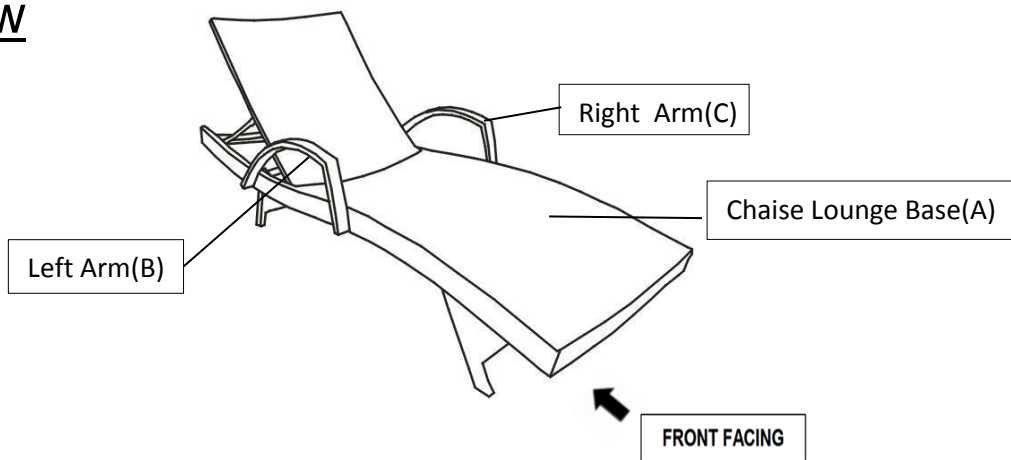
- Assemble on a clean non-marring surface (packing foam)-



- Save all packaging until finished-

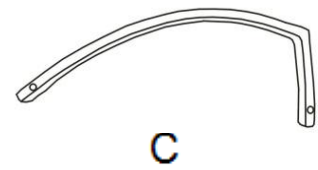
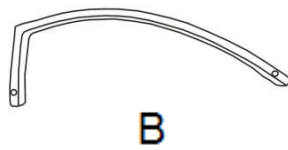
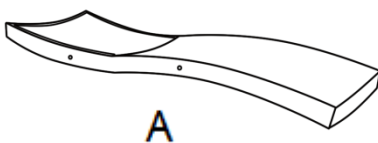
# Assembly Steps

## Overview



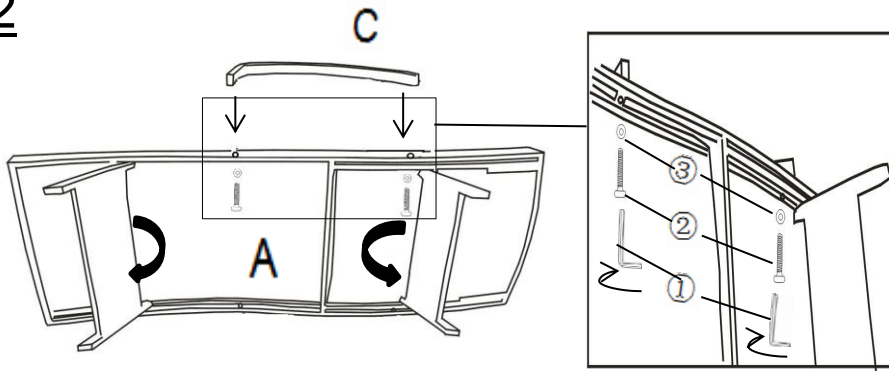
This Chaise Lounge has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Chaise Lounge parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

## Step 1



Open the carton, place all the parts onto a clean, non-marring surface, with the assistance of your adult partner.

## Step 2



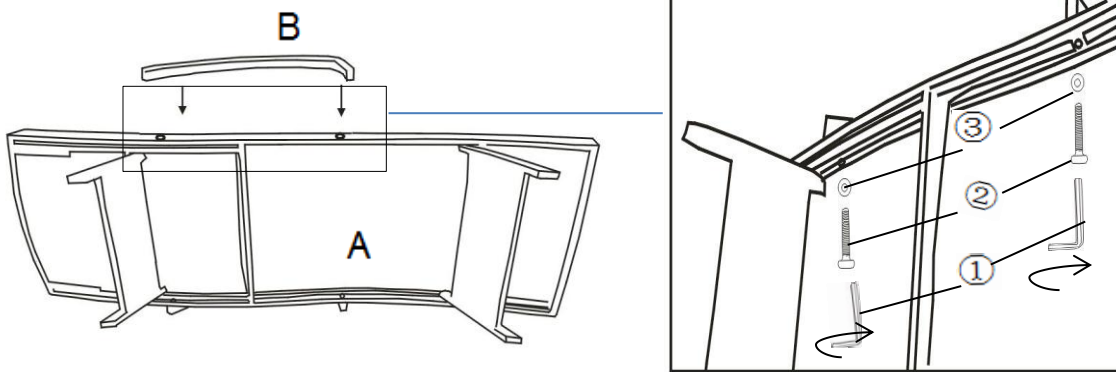
With the help of your adult partner, fold out the legs of Chaise Lounge Base(A) on a soft and clean surface.

Place Right Arm(C) onto the Chaise Lounge Base(A) as pictured.

Attach Right Arm(C) to Chaise Lounge Base(A) using Bolts(②) and Washers(③) with Allen Key(①).

**Because the bolts are not easy fully tighten at this stage, so fully tighten the bolts in step 3.**

## Step 3



With the help of your adult partner, carefully turn the Chaise Lounge Base(A) over.

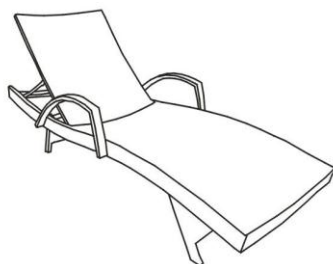
**Tighten the bolts of Step 2.**

Place the Left Arm(B) onto the Chaise Lounge Base(A) as pictured.

Attach Left Arm(B) to Chaise Lounge Base(A) using Bolts(②) and Washers(③) with Allen Key(①).

**Because the bolts are not easy fully tighten at this stage, you should carefully turn the chaise lounge over on the clean and soft surface with the help of your adult partner, fully tighten all bolts.**

## Step 4























With the help of your adult partner, stand the Chase Lounge right side up.

Your Chaise Lounge is ready for use.

**This Chaise Lounge can only be used on a flat, level surface.**

## Care & Maintenance

-   ● Do not put hot items directly on furniture surface
  -   ● Do not clean furniture with harsh cleansers or polish.
  -   ● To obtain the longest lifespan of your outdoor products, minimizing exposure to direct sunlight is recommended.
  -   ● Children should not climb or jump on the furniture.
  -   ● Do not write on furniture without a padded barrier to protect the surface.
  -   ● To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.
  -   ● Not for commercial use. For residential use only .
  -   ● Stains may be removed with mild soap solution and damp cloth.
  -   ● Keep away from sources of ignition.

-   ● Dust and pick-up spills using a clean, non-colored, lint-free cloth.

## Questions & Answers about Proposition 65

### • What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

### • What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

### • What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
