Warranty length may vary when purchased in other countries to conform to the legal requirements in those jurisdictions. This warranty is valid only if the purchase was made through an authorized Tribest reseller. All warranties are void when purchased through an unauthorized reseller.
- 2. Upon Tribest's® receipt of a written notice of defects from you during the warranty period, Tribest®, at its option, will either repair or replace the Tribest® Sedona Combo Dehydrator that proved to be defective. The replacement of the Tribest® Sedona Combo Dehydrator may be either new or like new. The Tribest® Sedona Combo Dehydrator may contain re-manufactured or re-conditioned parts, which is equivalent to new in performance or may have been subjected to incidental use.
- 3. This warranty does not apply to defects resulting from the following:
  - The failure to operate the Tribest® Sedona Combo Dehydrator in accordance with the instructions.
  - The use of parts or supplies not provided or authorized by Tribest®.
  - · Negligent, improper, or inadequate maintenance.
  - The service performed or attempted by unauthorized service person(s).
  - Tampering, misuse, or unauthorized modification of the Tribest® Sedona Combo Dehydrator.
