## 4. First-Aid Measures

## 10. Stability and Reactivity

## 11. Toxicological Information

**EFFECTS OF OVEREXPOSURE - EYE CONTACT:** Irritating, and may injure eye tissue if not removed promptly. Extremely irritating to the eyes and may cause severe damage, including blindness.
