<u>WHO IS COVERED</u>: This Warranty covers only the original retail purchaser of a John Deere consumer product or service part manufactured under license by Agri-Fab, Inc. It is not transferable.

<u>HOW LONG DOES COVERAGE LAST</u>: This Warranty remains in force for 2 years from the date of purchase; provided, however, that if the product is used commercially the Warranty remains in force for only 90 days from the date of purchase.

<u>WHAT IS COVERED</u>: Any defect in material or workmanship of your John Deere product or part.

<u>WHAT IS NOT COVERED</u>: Damage caused by misuse, excessive use, accident, neglect, alterations or operation or maintenance other than in accordance with instructions. This Warranty also does not cover the engine, if applicable, which may be covered by a separate limited warranty provided by the engine manufacturer, or any parts which may need to be replaced due to normal use of the product such as, but not limited to, belts and tires.

During the first year of ownership of the product, the current warranty will not change. For the second year of ownership the items listed below are not covered by or under the two (2) year limited warranty as they are considered "Wear Parts".
