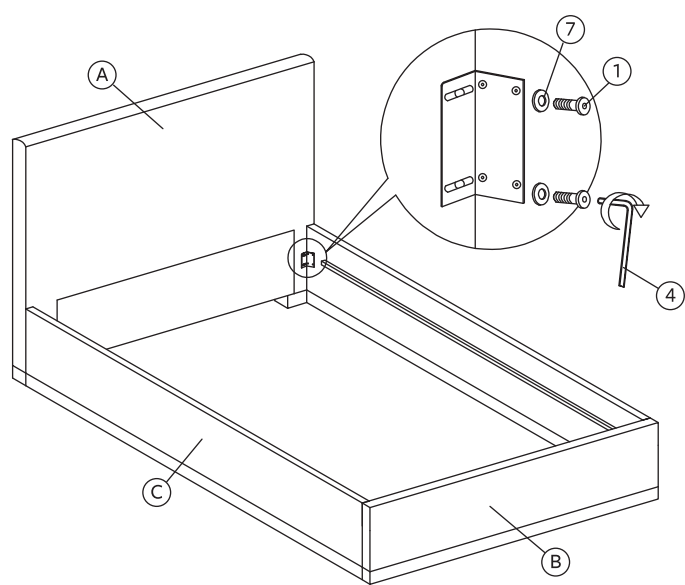
IMPORTANT

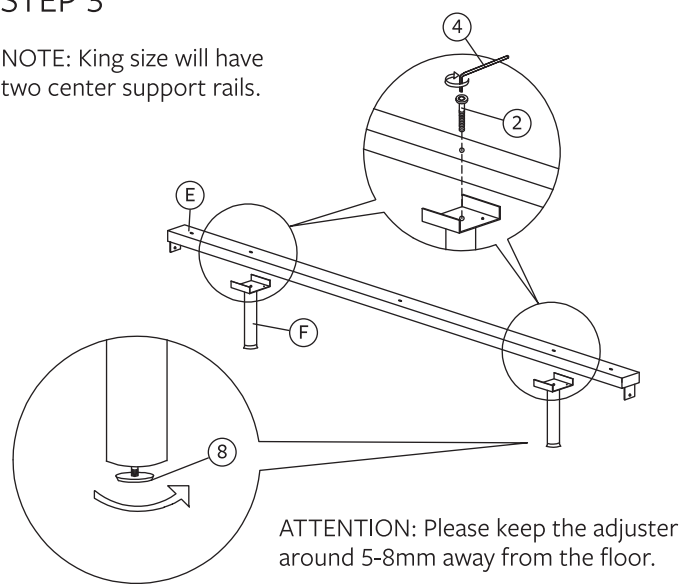

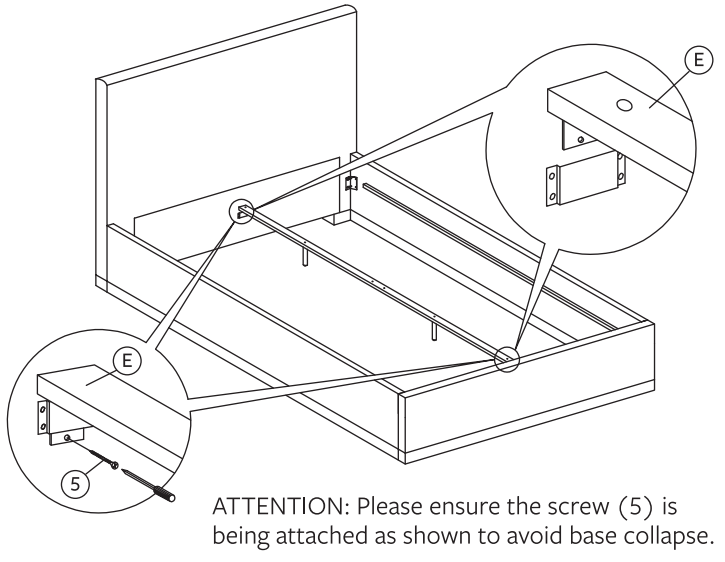

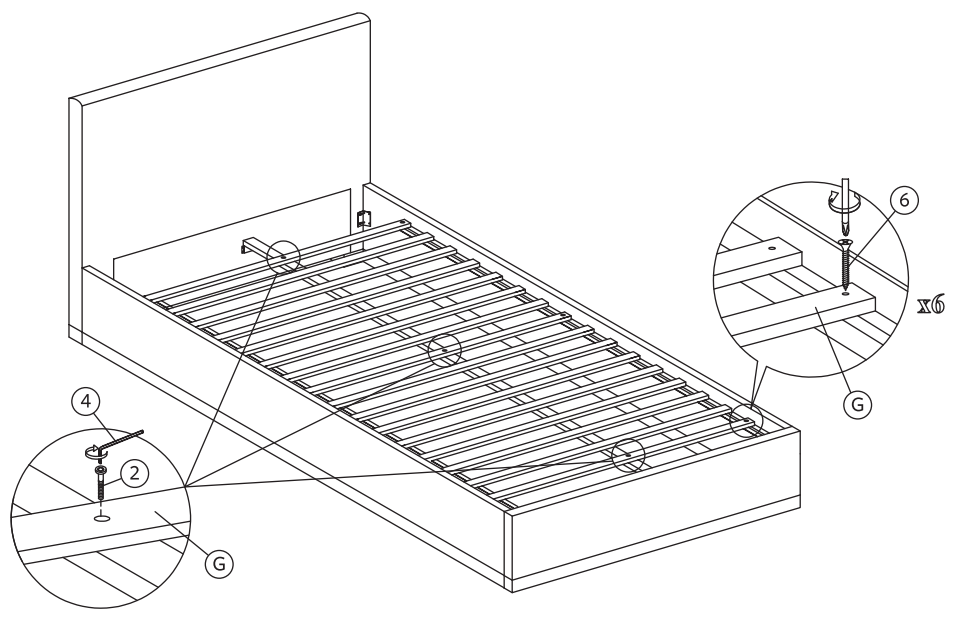
