BECAUSE THIS IS A NATURAL OCCURRENCE, NATURAL CONCRETE HARDSCAPES ACCEPTS NO RESPONSIBILITY OR LIABILITY FOR THIS CONDITION. OUR PRODUCTS ARE MADE FROM NATURAL, ENVIRONMENTALLY-FRIENDLY MATERIAL, AND THEREFORE, VARIATIONS IN COLOR MAY OCCUR.

THIS WARRANTY DOES NOT COVER THE NATURAL DETERIORATION OF THE STEEL RING INSERT OR COOKING GRATE, FOR THE FIRE PIT, DUE TO WEATHERING AND/OR HEAT EXPOSURE.
