## 4. First-Aid Measures

## 5. Fire-Fighting Measures

## 6. Accidental Release Measures

## 7. Handling and Storage

#### PERSONAL PROTECTION

Inhalable crystalline silica is listed by IARC as a group I carcinogen (lung) based on sufficient evidence in occupationally exposed humans and sufficient evidence in animals. Crystalline silica is also listed by the NTP as a known human carcinogen. Constituents may also contain asbestiform or non-asbestiform tremolite or other silicates as impurities, and above de minimus exposure to these impurities in inhalable form may be carcinogenic or cause other serious lung problems.
