TOILET BOWLS

Pour 1/2 cup into bowl and brush thoroughly, including under the rim.



LAUNDRY

Rub in full strength on grease spots or heavily soiled areas before washing. For extra cleaning and deodorizing power, add 1/2 cup to load. Use only on white or colorfast fabrics.
