

## Bamboo Composite Deck Tiles Limited 5-year Warranty

Naturesort warrants to the original purchaser ("Purchaser") that, under normal use and service conditions, Naturesort deck tiles are guaranteed against any manufacturers defect, including serious splitting, cracking or damage caused by insects, rot corrosion, fungal decay, or any physical polymer breakdown, for a period of five (5) years from the original date of purchase from Naturesort and is installed and maintained according to the Bamboo Composite DIY Deck Tiles Installation and Care & Maintenance Guide. Warranty is only valid to the original purchaser and is non-transferable.

If a defect occurs within the warranty period, Purchaser must, within thirty [30] days from discovery of the claimed defect but no later than the end of the warranty period, notify Naturesort in writing to the following email or physical address:

Purchaser must include in this notification, proof of purchase and statement & photos explaining the defect and date products were installed and installer information. Naturesort may request additional information, if needed. After reviewing all information, Naturesort will make a final decision regarding the claim. If Naturesort confirms this Purchaser's claim is valid, Naturesort's sole responsibility shall be to either replace the defective products or refund a portion of the purchase price paid by Purchaser for such defective products (not including the cost of its initial installation).

After the original purchase date, the Purchaser's recovery shall be prorated in the following manner:

This warranty shall not cover and Naturesort shall not be responsible for cost and expenses incurred with respect to the removal of defective Naturesort products or the installation of replacement materials, including but not limited to labor and freight.

This warranty may not be altered or amended except in a written instrument signed by Naturesort and Purchaser. No person or entity is authorized by Naturesort to make and Naturesort shall not be bound by any statement or representation as to the quality or performance of Naturesort products other than contained in this warranty.
