## CENTERPOINTE™ COUNTERTOPS Ninety-Day Limited Warranty

V-T Industries Inc. ("VT") warrants to the original purchasing consumer ("Purchaser") of CenterPointe countertop products ("Product") that the Product shall be free from defects in materials and workmanship for a period of ninety (90) days from the date of purchase subject to the following terms, conditions and exclusions.

This limited warranty applies only to Product in its original installation in the United States and is not transferable and expires upon resale or transfer by the Purchaser.

The Purchaser's sole and exclusive remedy against VT shall be limited to repair or replacement of Product only determined to be defective or refund of the purchase price of the defective Product only, as determined by VT in its sole discretion. In no event will VT's maximum liability exceed the amount paid by the Purchaser for Product only determined to be defective.

The following costs and expenses are not covered by the provisions of this limited warranty: (1) costs for the removal, fabrication and/or reinstallation of the Product; (2) shipping and freight expenses required to return the Product to VT; (3) normal maintenance; or (4) economic losses.

This limited warranty shall not apply to defects or damage arising from any of the following: (1) accidents, abuse or misuse; (2) improper fabrication or installation; (3) improper storage or handling; or (4) improper maintenance including damage from abrasive cleaners or harsh chemicals.

Product must be sanded and sealed or finished on all surfaces within 72 hours of removing shrink wrap. Be sure to read the care and maintenance instructions.

**NO OTHER WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, ARE MADE, INCLUDING, BUT NOT LIMITED TO, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT. UNDER NO CIRCUMSTANCES SHALL VT BE LIABLE FOR ANY LOSS OR DAMAGE ARISING FROM THE PURCHASE, USE OR INABILITY TO USE ITS PRODUCTS OR FOR ANY SPECIAL, PUNITIVE, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES. NO DEALER, DISTRIBUTOR, FABRICATOR, INSTALLER, AGENT OR EMPLOYEE OF VT HAS THE AUTHORITY TO ADD TO OR MODIFY THE OBLIGATIONS OR LIMITATION OF THIS LIMITED WARRANTY. THIS WARRANTY SHALL BE INTERPRETED EXCLUSIVELY UNDER THE LAWS OF THE STATE OF IOWA. VT RESERVES THE RIGHT TO REVISE OR TERMINATE THIS WARRANTY AT ANY TIME. ONLY PRODUCT PURCHASED FROM THE EFFECTIVE DATE OF THIS WARRANTY THROUGH THE DATE OF ANY REVISION OR TERMINATION OF THIS WARRANTY WILL BE COVERED BY THIS WARRANTY.**
