PRODUCT FINISH CARE INFORMATION

Lifestyle Solutions products are treated using only the finest finish ingredients. To ensure long-lasting enjoyment of your purchase, we recommend the following precautionary steps:

STAINING: Please ensure underside of furniture unit is wiped clean with cloth before placing to the desired location. Avoid dragging furniture on carpets to prevent possible staining.

NORMAL USE AND GENERAL CLEANING: Please clean surface using a damp (not wet) cloth followed by a clean dry cloth. Do not use aerosol products as they will harm the finish.

WATER RINGS AND SPOTS: Placing hot or cold beverages on wooden surface may cause damage to the finish. Please use a coaster and wipe dry any water spillage immediately.

SOLVENTS: Solvent-based polishes are flammable and toxic if swallowed. Once used, they cannot be completely removed. DO NOT USE SOLVENT-BASED POLISHES.

CANDLES: Lighting candles on furniture causes wax to drip and harden on finish. Scrape off thin layers using a plastic card, such as a credit card. Use a soft cloth and lemon oil to remove any final wax remnants.
