

# **ROTBLOC 4X4 POST WRAP**

## **10-Year Limited Warranty!**

**Finally, the warranty that most installers do not give!**

ROTBLOC LLC warrants to the original buyer of ROTBLOC 4X4 POST WRAP will be free from manufacturing defects and, if properly applied to pressure treated wood certified for ground contact by the AWPA treating standards, according to the installation instructions, as well as for the first time use of ROTBLOC 4X4 POST WRAP and said treated fence post or otherwise both products are new and unused and otherwise sound, will provide a protective barrier against the soil and the microorganisms found within the topsoil and thereby postponing the breakdown and decay of the pressure treated wood that the ROTBLOC 4X4 POST WRAP covers/ protects, subject to the limitations set forth below, for twenty (10) years from the date of purchase.

### Limitations on Warranty

This Limited Warranty is made to the original product purchaser and installation and is not transferable. Removal, reinstallation, or reuse of ROTBLOC 4X4 POST WRAP will void this Limited Warranty.

This Limited Warranty does not apply to any or all retrofitted installations using ROTBLOC 4X4 POST WRAPS. This includes previously installed pressure treated fence posts that ROTBLOC 4X4 POST WRAP is being retrofitted to or posts that have been previously installed in the ground and are being reinstalled.

This Limited Warranty applies only to the wood to which the ROTBLOC 4X4 POST WRAP barrier is applied. This Limited Warranty excludes any incidental or consequential damages, whether based upon breach of express or implied warranty, negligence, strict liability or any other legal theory.

This Limited Warranty applies only to ROTBLOC 4X4 POST WRAP that has been stored and handled properly prior to application and that has been applied to the pressure treated wood according to the ROTBLOC 4X4 POST WRAP guidelines and instructions.

This Limited Warranty does not apply if ROTBLOC 4X4 POST WRAP is used in extreme environments, or in contaminated soils.

This Limited Warranty does not apply to defects or failures caused by acts of God; falling or wind-blown particles or objects; external forces, including but not limited to machinery, insect and or termite damage, animals, persons, vandalism, or terrorism; explosions, fire, or other casualty; or damage to or decay of any portion of the wood post not covered by ROTBLOC 4X4 POST WRAP.

ROTBLOC 4X4 POST WRAP Limited warranty does not apply to any post that is not pressure treated per the AWPA standards for ground contact. Including but not limited to untreated wood, rot resistant species, dip-treated or posts treated but not treated to AWPA standards or treated not in conjunction with pressure are not covered under this warranty.

This Limited Warranty applies only to failures or defects of ROTBLOC 4X4 POST WRAP which are reported to ROTBLOC LLC within 30 Days from the date of failure of ROTBLOC 4X4 POST WRAP to perform as stated.

If ROTBLOC LLC determines that ROTBLOC 4X4 POST WRAP failed to perform as warranted herein, ROTBLOC LLC will, at its sole discretion, either (a) repair the post to which ROTBLOC 4X4 POST WRAP was applied; (b) replace the post; or (c) refund the ROTBLOC 4X4 POST WRAP buyer the price that the buyer paid for the post as well as the cost of purchase and installation of ROTBLOC 4X4 POST WRAP to said post.

ROTBLOC LLC can, will and must be allowed to research the cause of the post failure in order to qualify a claim and validate this warranty to the claimant. Person/s or Company filing claims must provide all requested documents validating their claim to ROTBLOC LLC including but not limited to receipts, photos, site visits or interviews with installers. Claim forms will be provided upon request.

**ROTBLOC LLC must at its sole discretion have the option to visit or have a third party perform a site visit of the actual post failure in person, "as it is" and undisturbed. Failure to allow ROTBLOC LLC the option to review the post failure "on site" before it is disturbed will result in voiding this warranty.**

ROTBLOC LLC MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, CONCERNING THE PRODUCT OR THE MERCHANTABILITY OR FITNESS THEREOF FOR ANY PURPOSE. IN NO EVENT SHALL ROTBLOC LLC BE RESPONSIBLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. Legal rights vary from state to state, so the above limitations may not apply to you if precluded by local law.
