## WARRANTY

Your appliance is covered by a One-Year Warranty. For one year from your original date of purchase, Mueller will pay costs for repairing or replacing any parts of this appliance that prove to be defective in materials or workmanship when such appliance is installed, used and maintained in accordance with the provided instructions.

### Exclusions

This warranty does not cover the following:

1. Products with original serial numbers that have been removed, altered or cannot be readily determined.
2. Product that has been transferred from its original owner to another party or removed outside the USA.
3. Rust on the interior or exterior of the unit.
4. Products used in a commercial setting.
5. Service calls which do not involve malfunction or defects in materials or workmanship, or for appliances not in ordinary household use or used other than in accordance with the provided instructions.
6. Service calls to correct the installation of your appliance or to instruct you how to use your appliance.
7. Expenses for making the appliance accessible for servicing, such as removal of trim, cupboards, shelves, etc., which are not a part of the appliance when it is shipped from the factory.
8. Damages to the finish of appliance or home incurred during installation, including but not limited to floors, cabinets, walls, etc.
9. Damages caused by: services performed by unauthorized service companies; use of parts other than manufacturer parts or parts obtained from persons other than authorized service companies; or external causes such as abuse, misuse, inadequate power supply, accidents, fires, or acts of God.
