

WARRANTY INFORMATION

The warranties herein set forth are in lieu of all other warranties expressed or implied, and shall not apply to any accessory not part of the product. King Electrical Mfg. Company will repair or replace, without charge to the original owner, any product found to be defective or malfunctioning within the warranty period.

One Year: K-Series Baseboard, EFW-Series, KT Kickspace, KAWH-Series, HFC1500 Table Top, Cove Heater, Utility Heater, Portable Baseboard, Portable Fan-Forced, RW-Series, Draft Barriers, MKT Series, KCA, KLA & KLI Cabinet Heaters, Thermostats, TVR. All product components are covered.

Two Year: W Heaters, LPWV Vandal Resistant, KBS Unit Heaters, SR Cable and H-Series Hydronic, KTW In-Counter Heater. All product components are covered.

Three Year: WHF Series

Four Year: PZ Series

Five Year: PAW-Series, LPW-Series, DAW-Series, SL-Series, LPWA-Series, KBP Series, KB Unit Heaters, KFUH Unit Heaters, KCC & KCF Cabinet Heaters, European Convectors, PKB Portable Unit Heaters, CB-Series Ceramic Baseboards and KFS, CK & CKL Electric Furnaces. Extended warranty applies to heating element only; all other components are covered for two years.

Ten Year: KDS Ceiling Diffusers carry a ten year warranty on the element. All other components are one year.

Twenty Year: KTM King Mat and FC Floor Heating systems carry a 20-year warranty on the heating wire, one year on the thermostat.

In Case of Product Failure: Contact King Electrical Mfg. Co. at 800.603.5464. The owner will be required to provide, within the designated warranty period, the following information: model number, date of purchase, and a complete description of the problem encountered with product. Upon receipt of the aforementioned, the company will reply to the owner within a period not to exceed fifteen (15) working days, and will provide the action to be taken by owner.

Terms: This warranty requires the owner or his agent install the equipment in accordance with the National Electrical Code, any other applicable heating or electrical codes and the manufacturer's installation instructions. It further requires that reasonable and necessary maintenance be performed on the unit. Failure of proper maintenance by owner will void the warranty in its entirety. The company is not liable for any actions it deems to be abuse or misuse of the product. The customer shall be responsible for all costs incurred in the removal or reinstallation of products, including, but not limited to labor costs, and shipping costs incurred to return products to King Manufacturing. At their discretion, King Manufacturing will decide to either repair or replace the product, with no charge to the owner, with return freight paid by King.

The Company shall not be liable for consequential damages arising with respect to the product, whether based upon negligence, tort, strict liability or contract. No other written or oral warranty applies, nor any warranties by Representatives, Dealers, Employees of King or any other person.
