How long does the coverage last?

The limited warranty lasts 10 years from the date of initial purchase. Sales receipt, invoice, or other proof that the product is within warranty period is required for proof of purchase.

What will Rubbermaid Commercial Products do?

RCP will refund you the pro-rated portion of the purchase price of the product on a straight-line depreciated basis of 10% per year. For example, if the product has been owned for 7 years, RCP will refund you 30% of the original purchase price.

What does this warranty not cover?

The warranty applies only to the original purchaser/owner and is not transferrable. This warranty is void if the item is repaired or modified. All failures or defects must be reported within the warranty period. Any use of the product for purposes other than its intended use will void this limited product warranty.

Damage caused by: insects, animals or rodents, use of force, incorrect handling, inappropriate use, abuse, neglect, accidents, impacts from foreign objects, vandalism, pollutants, alteration, or damage caused as a result of storage above capacity limits of the product, are not covered by this limited warranty. This limited warranty does not apply to damage resulting from “acts of nature” such as, but not limited to wind, hail, storm, tornado, hurricane, heavy snow, ice, blizzard, flood, fire effects. This warranty does not apply to “normal weathering”. “Normal weathering” is defined as exposure to sunlight and extremes of weather and atmosphere which will cause any colored surface to gradually fade, chalk, or accumulate dirt or stains.

How do you get service?

RCP will issue a refund when the consumer provides a proof of purchase (either a bill of sale, receipted invoice, or other proof that the product is within the warranty period), along with a full description of the defect, to www.rubbermaidcommercial.com/contact-us/ or Toll Free (800) 347-9800 Monday – Friday, 8:00 a.m. – 5:00 p.m. Eastern. RCP reserves the right to request photographic proof of product defect, and request that the defective product in question be shipped to RCP (postage provided by RCP) to verify the defect or to aid in quality control efforts.

THIS LIMITED WARRANTY IS EXCLUSIVE AND IN LIEU OF ANY OTHER WARRANTY, WRITTEN OR ORAL, INCLUDING BUT NOT LIMITED TO ANY EXPRESS WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. THE DURATION OF ANY IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, IS EXPRESSLY LIMITED TO THIS LIMITED WARRANTY PERIOD. Legal rights vary from state to state and some states do not allow limitations on how long an implied warranty lasts; therefore, the above limitations may not apply to you if precluded by local law.

THE CUSTOMER'S EXCLUSIVE REMEDY FOR BREACH OF THIS LIMITED WARRANTY OR OF ANY IMPLIED WARRANTY OR OF ANY OTHER OBLIGATION ARISING BY OPERATION OF LAW OR OTHERWISE SHALL BE LIMITED AS SPECIFIED HEREIN TO REFUND, AT OUR SOLE OPTION. IN ANY EVENT, RESPONSIBILITY FOR SPECIAL, INCIDENTAL AND CONSEQUENTIAL DAMAGES IS EXPRESSLY EXCLUDED.
