### **Methods and materials for containment and cleaning up**

- Spill** : Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. 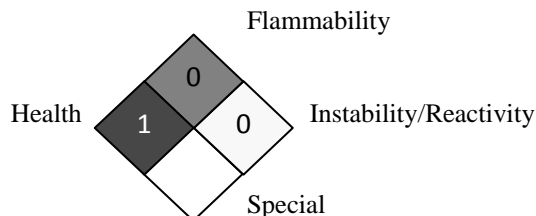
