

HANSEN POLE BUILDINGS LIMITED LIFETIME WARRANTY

COVERAGE

Lifetime: Structural Building Columns, pressure preservative treated under AWPA Standard UC1-07 to use category UC4B, commodity section A, which fail due to decay or insect attack.

Lifetime: Pre-fabricated roof trusses which fail from snow loads, and have never been subjected to roof snow load conditions greater than their original design.

Lifetime: Main windforce-resisting system members, which fail from wind loads, and have never been subjected to wind load conditions greater than their original design.

LIMITATIONS

This Warranty is extended only to the original purchaser of an engineer sealed Premier Hansen Pole Building kit. These warranties may not be transferred or assigned. Building must be fully constructed at site address indicated on plans, on non-commercial property owned by purchaser at time of purchase and of claim. Hansen Pole Buildings will not be liable for damage caused by flying or falling objects, tornados, floods, external forces, explosions, fire, riots, civil commotion, acts of God or war, radiation, natural perils or other similar or dissimilar occurrences and causes beyond the control of Hansen Pole Buildings, nor for losses, damage or expense, whether direct, incidental or consequential, caused by or resulting from any defective or nonconforming products.

This warranty is void in situations when:

- Installation of any building component, whether covered under this warranty or not, is not made in full accordance with the engineered plans and instructions furnished by Hansen Pole Buildings.
- The actual operation or use of any component or building varies from the original operating instructions or intended use.
- c. There is a malfunction or defect resulting from misuse, neglect, negligence, vandalism, accidents, or lack of performance of any required maintenance by the original purchaser.
- d. The building or building site are altered or added onto, in any way, unless engineered design and materials were provided by Hansen Pole Buildings.
- e. Building is not fully enclosed, with doors and windows tightly shut during storm conditions.
- f. Abnormal atmospheric conditions exist, including but not limited to hail, ice storms or ice accumulation, exposure to harmful chemicals, animal wastes, salt water spray, decaying materials, wet absorptive material or other contamination.

PURCHASER'S OBLIGATION

Purchaser expressly agrees to fully and timely pursue all available remedies under any applicable insurance agreements before making claim under this warranty. Insure building with maximum \$250 deductable. All warranty claims must be made in writing to Hansen Pole Buildings, LLC; Warranty Department; 12167 Lake Road; Browns Valley, MN 56219, by USPS certified mail, return receipt requested, within the warranty period.

EXCLUSIVE REMEDY

If any of our Product fails to perform as warranted, Hansen Pole Buildings will, at its option, provide a replacement, or refund the purchaser the price originally paid by Hansen Pole Buildings for the Product(s).

This warranty is the only warranty applicable and is expressly in lieu of all other warranties, written or oral, express or implied, including any warranty of merchantability or fitness for a particular purpose.
