## **SECTION 6. ACCIDENTAL RELEASE MEASURES**

Methods and materials for containment and cleaning up

Flush away traces with water. For large spills, dike spilled material or otherwise contain material to ensure runoff does not reach a waterway.

### **SECTION 7. HANDLING AND STORAGE**


