Mechanical components such as spray head assembly (includes engine, aerators, structure, restrictors, back flow preventers, sprayer hoses, braided supply line hoses, etc.) are warranted to be free of defects in material and workmanship under normal usage for a period of one (1) year under this warranty. AKDY further warrants mechanical component (cartridge) to be free from defects in material and workmanship under normal usage for a period of five (5) years. The warranty commences from the initial date of purchase by the original owner.

Reported and proven defective product, used solely in a residential application and installed in accordance with the AKDY installation instructions, will be covered by this warranty for repair or replacement of equal value.

All incidental or consequential damages are specifically excluded.
