



Klean-Strip® Odorless Mineral Spirits

is a premium, highly refined solvent formula which effectively thins and blends well into oil-based paint, stain and varnish. It is very low odor and dries with no residue and is an excellent cleaner for brushes and equipment.

DIRECTIONS FOR USE:

Follow the paint product manufacturer's instructions for the proper amount of Odorless Mineral Spirits required. We recommend starting with 4 oz. per gallon. Do not use more than recommended. Add gradually and stir thoroughly until desired consistency is obtained. Do not use as a thinner for latex paint or other water based coatings, lacquer or shellac.

IMPORTANT: Carefully read all directions, notes and cautions prior to use. Only use this product as directed on the label. Do not apply to floors or any other large surface areas because fire and health safety risks will increase dramatically. Protect eyes with chemical splash goggles and avoid prolonged skin contact.

STORAGE: Do not use or store this product near any source of heat or open flame, furnace areas, pilot lights, stoves, etc. Keep it in a cool, dry place, out of direct sunlight, at temperatures below 120°. Keep container closed when not in use. Do not reuse this container.

DISPOSAL: If container is corroded, rusted or shows signs of deterioration, dispose of product. Dispose of empty cans and leftover product at your local household hazardous waste collection facility. If one is not available, dispose of in accordance with federal, state and local regulations.
