2. Hazard(s) identification

(c) Description of any hazards not otherwise classified

In case of mistreatment (abusive over charge, reverse charge, external short circuit...) and in case of fault some electrolyte can leak from the cell through the safety device. In these cases refer to the risk of the electrolyte. Contact with internal components may cause irritation or severe burns. Irritating to eyes, respiratory system, and skin. The electrode materials are only hazardous, if the materials are released by mechanical damaging of the cell or if exposed



to fire.

Skin touch: Contact with battery electrolyte may cause burns and skin irritation.

4. First-aid measures

(a) Description of first aid measure

Inhalation: Remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical

5. Fire-fighting measures

(a) Extinguishing media

(b) Special hazards arising from the chemical

Under fire conditions, batteries may burst and release hazardous decomposition products when exposed to a fire situation. This could result in the release of flammable or corrosive materials. Hazardous combustion products: CO, CO2, Metal oxides, Irritating fumes

(c) Special protective equipment and precautions for fire-fighters

Firefighters must wear fire resistant protective equipment and appropriate breathing apparatus. The staff must equip with filter mask (full mask) or isolated breathing apparatus. The staff must wear the clothes which can defense the fire and the toxic gas. Put out the fire in the upwind direction. Remove the container to the open space as soon as possible. Spray water on the containers in the fireplace to keep them cool until finish extinguishment.

6. Accidental release measures

(a) Personal precautions, protective equipment and emergency procedures

If the battery material is released, remove personnel from area until fumes dissipate. Provide maximum ventilation to clear out hazardous gases. The preferred response is to leave the area, dispose the case after the batteries cool and vapors dissipate. Provide maximum ventilation. Avoid skin and eye contact or inhalation of vapors.

(b) Methods and materials for containment and cleaning up

If battery casing is dismantled, small amounts of electrolyte may leak. Collect all released material in a plastic lined container. Dispose off according to the local law and rules. Avoid leached substances to get into the earth, canalization or waters.

7. Handling and storage

(a) Precautions for safe handling

Always follow the warning information on the batteries and in the manuals of devices. Only use the recommended battery types. Keep batteries away from children. For devices to be used by children, the battery casing should be protected against unauthorized access. Unpacked batteries shall not lie about in bulk. In case of battery change always replace all batteries by new ones of identical type and brand. Do not swallow batteries. Do not throw batteries into water. Do not throw batteries into fire. Avoid deep discharge. Do not short-circuit batteries Use recommended

charging time and current.

(b) Conditions for safe storage, including any incompatibilities

If the Lithium-ion Polymer Battery is subject to storage for such a long term as more than 3 months, it is recommended to recharge the Lithium-ion Polymer Battery periodically. Operating temperature: Charge: 0° C ~45 $^{\circ}$ C. Discharge: -20° C ~60 $^{\circ}$ C And recommended at -20° C ~45 $^{\circ}$ C for 1 month storage, at -20° C ~35 $^{\circ}$ C for 3 months storage. The capacity recovery rate in the delivery state (50% capacity of fully charged) after storage is assumed to be 80% or more. The voltage for a long time storage shall be 7.4V~8.4V range. Do not storage Lithium-ion Cylindrical Battery haphazardly in a box or drawer where they may short-circuit each other or be short-circuited by other metal objects. Keep out of reach of children.

The transport vehicle and ship must be cleaned and sterilized otherwise it is not allowed to assemble articles. During transport, the vehicle should prevent exposure, rain and high temperature. For stopovers, the vehicle should be away from fire and heat sources. When transported by sea, the assemble place should keep away from bedroom and kitchen, and isolated from the engine room, power and fire source. Under the condition of Road Transportation, the driver should drive in accordance with regulated route, don't stop over in the residential area and congested area.
