 Do not shake.
- For best results, use at temperatures between 60°F (16°C) and 90°F (32°C).
- Apply with a synthetic bristle brush or foam brush.
- Allow Wood Effects to sit on the wood for 30 minutes to 1 hour for the final effect. Wiping away is not required.
- For a lighter effect, apply product and wipe away immediately or lightly sand the finish with fine grit sandpaper once it is dry.
 To darken, a second coat can be applied after 1 hour.

CLEAR FINISH APPLICATION

- A topcoat is necessary for the best protection.
- Wait 1 hour for Wood Effects to dry before applying clear topcoat.
- For best results, use BEHR® Water-Based Fast Drying Polyurethane as a protective top coat. Test in an inconspicuous area first.
