Precautions for safe handling

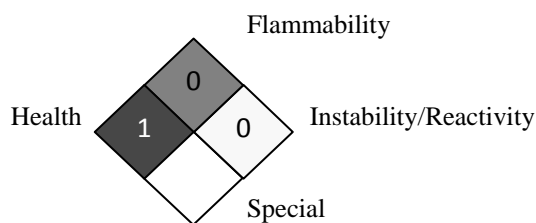
