General Properties: Highly concentrated wallpaper remover designed to minimize the time and effort required to remove wallpaper. The 32 oz. container yields 5 gallons of remover; the 1 gallon container yields 20 gallons of remover.

Coverage: Up to approx. 250-300 square feet per gallon

VOC (actual): 0% as calculated per EPA Method 24, when diluted to recommended concentration

Storage: Avoid freezing; keep in cool, dry place

Application Instructions

Surface Preparation: Vinyl or vinyl coated wallcoverings must be perforated with a Piranha™ Scoring Tool to allow penetration of the remover.

Dilution: Add 6 oz. of concentrate to every 1 gallon of hot tap water (120°F)

Application Method: Use when the room temperature is 60-70°F. Apply with a low pressure, low atomization sprayer, such as a garden sprayer. Remover may also be sponged on.

Removing Wallcovering: Apply remover to the scored wallpaper. Let soak for 15 minutes. Use Piranha™ Scraper with Roller and start scraping from ceiling down. Reapply remover as it absorbs.

Removing Paste Residue: Apply remover to wall and let soak for 15 minutes. Scrub residue with Piranha™ Removal Sponge. Reapply remover as it absorbs. Rinse wall thoroughly with clean water.

Clean-Up: Rinse wall thoroughly with clean water. Allow wall surface to dry thoroughly before hanging wallcovering.
