Walkers Jr Active Instructions

NOTE: This active hearing protection & supplied audio cable is not toy. Use only as directed.

Installing Batteries

Unscrew the retention screw on the battery door using a small Phillips screw driver. Insert 2 "AAA" batteries in the correct polarity (+/-). Replace the battery door and secure with the retention screw.

Proper fitting

Ensure that the muff cups completely cover your child's ears. Adjust the headband to provide a secure comfortable fit.

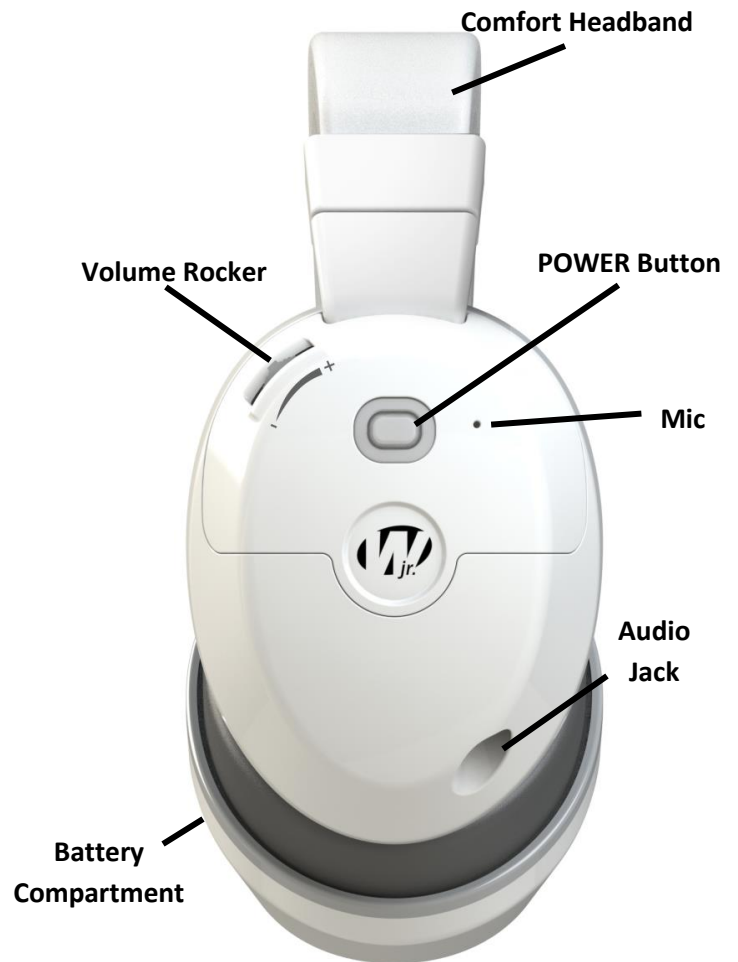
Operation

Power on - press the power button, the green LED will illuminate indicating power is on.

Power off - press and hold the power button for 3 seconds, the LED will go out indicating power is off.

Volume control - push the rocker dial up to increase volume, down to decrease.

Audio input - to use the audio input feature use the supplied cord. Plug one end into the hear muff and the other end into the audio source such as an iPad. Use the devices volume controls to control the sound level.



LIMITED WARRANTY

Walker's warranties this product to the original purchaser to be free from defects in materials and workmanship, under normal use and conditions for a period of one year parts from the date of purchase.

Under this warranty, this unit will be replaced or repaired at our option. Copy of original receipt or gift receipt, is required for any warranty service. To enact the warranty, the customer is required to contact our Customer Service Group at 877-269-8490 to receive an Return Authorization (RA) number **PRIOR** to sending the product back.

This warranty is void if any of the following occur:

1. The unit is not accompanied by a copy of the receipt or gift receipt from the original purchaser.
2. The unit has been tampered with, opened or punctured.
3. The unit has been immersed in water or other liquids, allowed to be filled with dirt or dust, or otherwise physically abused.
4. The one year limited warranty has expired. Please inquire about other options from your Customer Service Representative.
