Optimus Enterprise, Inc. warrants to its customers and/or consumer of this electric fan and the parts thereof will be free from defect in material and workmanship, under normal use, for a period of one (1) year from the date of initial purchase. The warranty does not apply to repairs necessitated by damage, misuse, abuse or alteration and to any repairs of merchandise not used within the United States unless otherwise prescribed by law. Optimus Enterprise, Inc. shall not be liable for any personal injury, property damage or any incidental or consequential damages of any kind (including water damage) resulting from malfunctions, defects, misuse, improper installation or alteration of this product. This warranty is the only warranty extended by Optimus Enterprise, Inc. to its original customers and/or consumers purchasing fan, Optimus Enterprise, Inc. disclaims all other warranties, expressed or implied, that arise by the operation of law, specifically including the implied warranties of merchantability and fitness for a particular purpose. Optimus Enterprise, Inc. shall not be liable for any incidental or consequential damage, which may have resulted from any alleged breach of warranty. Some states do not allow limitations on how long implied warranty lasts or the exclusion or limitation of consequential damage, so the above limitations or exclusion may not apply to you. This warranty gives you specific legal rights you may also have other rights which vary from state to state.

Should the fan fail during the warranty period, the owner should:

- Within the first 30 days from date of purchase, the store from which you purchased your Optimus product should replace this product if it is defective in material or workmanship (provided the store has in-stock replacement).
- Within the first 12 months from date of purchase, Optimus Enterprise, Inc. will repair or replace the product if it is defective in material or workmanship providing it is returned to Optimus Enterprise, Inc. with freight prepaid, with evidence of purchase date (cash register receipt) together with see below for fee CHECK OR MONEY ORDER for handling and return packaging/shipping charges..
