SPEX Lighting provides a lifetime warranty for our products and warrants that they will not fail for the product's life cycle. Should this product, in SPEX Lighting's opinion, fail to operate as per its intended use during the warranty period, SPEX Lighting will, at its option, repair or replace the covered product only at no charge; provided that the product has not been subjected to abuse, misuse, accident, disaster and or non-SPEX Lighting authorized modification or repair. All electrical connections must be completed by a licensed electrician.

SPEX Lighting extends a lifetime warranty only to the original purchaser or to the first user. Proof of purchase, must include receipt with date of purchase, proof of installation. The receipt must include date of installation, electrical contractor name and license number.

This warranty excludes SPEX liability for material shipping charges, any labor for removal or reinstallation of this product. This warranty is void if this product is installed improperly or in an improper environment, overloaded, misused, opened, abused, or altered in any manner, or is not used under normal operating conditions or not in accordance with any warning labels or installation instructions.
