Limited Warranty: Utilite™ composite wall and ceiling panels distributed by Nudo Products, Inc., 1500 Taylor Avenue, Springfield, IL 62703 are warranted for a period of Two (2) years from the date of purchase to be free from substantial defects in material and workmanship. This warranty is extended only to the original purchaser from authorized dealers and/or distributors and is non-transferable and subject to the terms, requirements and limitations provided in this limited warranty.

Limited Warranty Coverage: Panels covered under this warranty are warranted for a period of two (2) years from date of purchase to:

- 1. Be free from substantial defects in material and workmanship.
- 2. Not rot, rust, corrode, develop structural surface cracks or require painting or refinishing.

Condition of Warranty and Exclusions: Nudo Products, Inc. will at its option, upon documentation and verification of failure, repair or replace the panels, without charge, the above referenced product if it fails due to the above defects.
