

### Clear the Work Area

- · Always clear the work area of foreign objects such as rocks, broken glass, nails, wire, or string, which can be thrown or become entangled in the cutting attachment, and check for any hidden hazards. # WARNING

The term "power tool" in the warnings refers to your mains-operated (corded) power tool or battery-operated (cordless) power tool.

## **Work Area Safety**

- · Keep work area clean and well lit. Cluttered or dark areas invite accidents.
- Do not operate power tools in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Power tools create sparks which may ignite the dust or fumes.
- Keep children and bystanders away while operating a power tool. Distractions can cause you to lose control.

# **Electrical Safety**

- Power tool plugs must match the outlet. Never modify the plug in any way. Do not use any adapter plugs with earthed (grounded) power tools. Unmodified plugs and matching outlets will reduce the risk of electric shock.

- · When operating a power tool outdoors, use an extension cord suitable for outdoor use. Use of a cord suitable for outdoor use reduces the risk of electric shock.
- · If operating a power tool in a damp location is unavoidable, use a ground fault circuit interrupter (GFCI) protected supply. Use of a GFCI reduces the risk of electric shock.

# **Personal Safety**

# **Proper Clothing**

## **Battery Tool Use and Care**

- Recharge batteries only with ECHO eFORCE<sup>®</sup> 56V battery series chargers. A charger that is suitable for one type of battery may create a risk of fire when used with another battery.
- Use only with ECHO eFORCE<sup>®</sup> 56V battery series. Use of any other battery may create a risk of injury and fire.
- · When battery is not in use, keep it away from other metal objects, like paper clips, coins, keys, nails, screws or other small metal objects, that can make a connection from one terminal to another. Shorting the battery terminals together may cause burns or a fire.

When using electric trimmers, lawn edgers, cultivators, and pole pruners basic safety precautions should always be followed to reduce the risk of fire, electric shock, and personal injury, including the following:

### READ ALL INSTRUCTIONS.

- Avoid Dangerous Environment Don't use appliances in damp or wet locations.
- 2. Don't Use in Rain.
- 3. Keep Children Away - All visitors should be kept at a distance from work area.
- Dress Properly Do not wear loose clothing or jewelry. They can be 4. caught in moving parts. Use of rubber gloves and substantial footwear is recommended when working outdoors. Wear protective hair covering to contain long hair.
- 5. Use Safety Glasses - Always use face or dust mask if operation is dusty.
- 6. Use Right Tool - Do not use tool for any job except that for which it is intended.
- 7. Avoid Unintentional Starting - Don't carry tool with finger on switch. Be sure switch is off when plugging in.
- 8. Don't grasp exposed cutting blades or cutting edges when picking up or holding the tool.

9. Don't Force Tool - It will do the job better and with less likelihood of a risk of injury at the rate for which it was designed.

- 10. Don't Overreach Keep proper footing and balance at all times.
- 11. Stay Alert Watch what you are doing. Use common sense. Do not operate appliance when you are tired.
- 12. Store Idle Tools Indoors When not in use, tools should be stored indoors in dry, locked place out of reach of children with the battery removed.
- 13. Maintain Tool with Care Keep cutting edge sharp and clean for best performance and to reduce the risk of injury. Follow instructions for lubricating and changing accessories. Keep handles dry, clean, and free from oil and grease.
- 14. Check Damaged Parts Before further use of the appliance, a guard or other part that is damaged should be carefully checked to determine that it will operate properly and perform its intended function. Check for alignment of moving parts, binding of moving parts, breakage of parts, mounting, and any other condition that may affect its operation. ### 15. Edger

- · Keep guards in place and in working order.
- Keep metal blades sharp.
- · Keep hands and feet away from cutting area

### 16. Cultivator

· Keep hands away from blades.

### 17. Pole Pruner

- Keep all parts of the body away from the saw chain. Do not remove cut material or hold material to be cut when blades are moving. Make sure the switch is off when clearing jammed material. Saw chain continues to move after the switch is turned off. A moment of inattention while operating the extended-reach pruner may result in serious personal iniurv.
- · Carry the extended-reach pruner by the handle with the saw chain stopped. When transporting or storing the extended-reach pruner, always fit the saw chain device cover. Proper handling of the extendedreach pruner will reduce possible personal injury from the saw chain.
- · Hold the extended-reach pruner by insulated gripping surfaces only, because the saw chain may contact hidden wiring. A saw chain contacting a "live" wire may make exposed metal parts of the extended-reach pruner "live" and could give the operator an electric shock.





• Do not operate the charger in explosive atmospheres, such as in the presence of flammable liquids, gases or dust. Charger can produce sparks which may ignite the dust or fumes - there is a risk of explosion.

- Connect the charger only to the mains of voltage and frequency specified on the rating plate.
- Connect the charger only to an easily accessible wall outlet.
- · Never insert objects in the battery's or charger's cooling slots.
- Do not charge or use a defective, damaged or deformed battery and charger.
- Do not open, damage or drop the battery or the charger.
- Fluid may leak from the battery if it is damaged or not used properly; avoid contact with the skin. In the event of accidental contact, wash the affected areas of the skin with plenty of water and soap. If fluid gets in the eyes, do not rub. Rinse the eyes with plenty of water for at least 15 minutes. Also seek medical assistance.
- Never bridge (short circuit) the battery contacts or the charger's terminals with metallic objects.
