INSTALL INSTRUCTIONS



STEP 1

Make sure your fire pit coping is within the recommended size range.

X19: 22-26 in.

X24: 27-33 in.

X30: 34-39 in.

STEP 2

Center the insert ring on the opening.

STEP 3

Line up the legs of your Breeo X Series® smokeless fire pit with the notches on the Insert Ring.

STEP 4

Lower your X Series fire pit into the Insert Ring until the rim lays flat on the edge of the Insert Ring.

BREEO TIP

We always recommend lifting and lowering your Breeo X Series smokeless fire pit into your Insert Ring with the help of a friend. We consider it a two-person job.



FOR YOUR SAFETY

The X Series Insert Ring may have some sharp edges - it is recommended to use gloves for this install.

We recommend having two people lift and lower the fire pit into the X Series Insert Ring.

All surfaces of the X Series Insert Ring will become extremely hot when fire pit in use. To avoid burns, don't touch any part of the Insert Ring until it's completely cool (unless you're using protective gear like hot pads, potholders, etc.).

This Insert Ring is designed for outdoor use only. **Never use your X Series Insert Ring in a building, garage, or any enclosed area.**

Always place your Insert Ring on a level, fireproof surface such as rock, stone or dirt. **Never use your X Series Insert Ring on wooden or composite decks, stamped concrete or any heat sensitive surface.**
