If covered, CASTELLO USA will suggest possible solutions with you to resolve the issue. This warranty extends to the original purchaser and first consumer for personal household use only.

## The One Year Limited Warranty does not cover the following:

- Normal wear and tear due to standard use.
- Costs due to labor, installation, or removal.
- Any shipping fees including freight, transportation, or postage.
- Injury or bodily harm due to use of a product.
- Issues that are not related to defects of the product (such as buyer's remorse, failure to purchase the correct size, personal dislike of color or finish, etc).
- Products that were damaged during shipping or transit.\*
- Damages to product or property or bodily harm due to:
  - Negligence
  - Abuse
  - Excessive use of chemicals
  - Improper maintenance
  - Improper usage
  - Improper repairs
  - Improper installation

The One Year Limited Warranty will be rendered void including but not limited to the following situations:

- Products that have been modified.
- Products that have been moved from their initial place of installation.
- Products that were received in an imperfect state but were installed and used regardless.
- Products that were not installed by a professional licensed contractor or plumber.\*\*

Please note that replacement units and parts have additional shipping and handling charges depending on the location the replacements are being shipped to. Any shipment to Alaska, Hawaii, Puerto Rico, any offshore islands (including Manhattan, Long Island, Martha's Vineyard, the Florida Keys), or any international location (including Canada and Mexico) will be subject to additional shipping and handling charges. Shipments to locations not listed above may have additional charges depending on the situation. Charges will be determined on a case-by-case basis depending on the location and the item being shipped.
