USG Sheetrock<sup>®</sup> Brand Mold Tough<sup>®</sup> Panels Firecode<sup>®</sup> X are 5/8 in. (15.9 mm) Type X panels that feature a noncombustible, moisture- and mold-resistant gypsum core that is encased in moistureand mold-resistant, 100% recycled green face and brown back papers. When tested in accordance with ASTM D3273, *Standard Test Method for Resistance to Growth of Mold on the Surface of Interior Coatings in an Environmental Chamber*, the panels meet or exceed ASTM C1396 specifications. The long edges of the panels are tapered, allowing joints to be reinforced and concealed with USG Sheetrock<sup>®</sup> Brand joint treatment systems. The panels are UL Classified for fire resistance and can be used in any UL design in which Type SCX panels are listed. On the face along the long edge of each panel, the UL Type Designation is printed for easy identification by building inspectors.

- Commercial or residential applications where 5/8 in. (15.9 mm) moisture- and mold-resistant Type X panels are required
  - New or repair and remodel construction

- 1. Avoid exposure to sustained temperatures exceeding 125 °F (52 °C).
- **2.** Avoid exposure to excessive, repetitive or continuous moisture before, during and after installation. Eliminate sources of moisture immediately.
- **3.** Must be stored off the ground and under cover in accordance with Gypsum Association's GA-801, *Handling and Storage of Gypsum Panel Products*.
- **4.** Not suitable for use as a substrate for tile in wet areas such as tubs and showers, gang showers and other areas subject to direct water exposure.
- 5. Use as a tile substrate is limited to tile installed according to the most current TCNA and ANSI specifications. Please consult with the adhesive and tile manufacturers for their recommendations for maximum size and weight parameters for use with gypsum board.
- **6.** Not recommended for exterior soffits and ceilings which project upwards and away from the building proper.



# INTERIOR INSTALLATION, FINISHING AND DECORATING

For maximum framing spacing in non-fire-resistance-rated applications of gypsum panel products, refer to Gypsum Association's GA-216, *Specifications for the Application and Finishing of Gypsum Panel Products* or ASTM C840, *Standard Specification for Application and Finishing of Gypsum Board*. For fire-resistance-rated applications, refer to the published UL Design or GA File Number.

#### Note:

1. On ceilings to receive water-based texture material, 5/8 in. (15.9 mm) gypsum board shall be applied either parallel to framing spaced at 16 in. (406 mm) OC or perpendicular to framing spaced maximum 24 in. (610 mm) OC. See Appendix A.3 of Gypsum Association's GA-216, Specifications for the Application and Finishing of Gypsum Panel Products for more information.

For high-quality finishing results, USG recommends USG Sheetrock® Brand finishing products.

Painting products and systems should be used that comply with recommendations and requirements in Appendices of ASTM C840. For priming and decorating with paint, texture or wall covering, follow manufacturer's directions for materials used. Gypsum Association's GA-214, *Recommended Specification for Levels of Gypsum Board Finish* should be referred to in order to determine the level of finishing needed to ensure a surface properly prepared to accept the final decoration.

All surfaces, including applied joint compound, must be thoroughly dry, dust-free and not glossy. Prime with USG Sheetrock<sup>®</sup> Brand First Coat<sup>™</sup> Primer or with an undiluted, interior latex flat paint with high-solids content. Allow to dry before decorating.

To improve fastener concealment where gypsum panel walls and ceilings will be subjected to critical artificial or natural side lighting, or will be decorated with a gloss paint (eggshell, semigloss or gloss), the gypsum panel should be skim coated with joint compound. This equalizes suction and texture differences between the drywall face paper and the finished joint compound before painting. When a Level 5 finish is required, use USG Sheetrock<sup>®</sup> Brand Tuff-Hide<sup>™</sup> Primer-Surfacer. See USG Sheetrock<sup>®</sup> Brand Tuff-Hide<sup>™</sup> Primer-Surfacer Submittal Sheet (J1613) for limitations and application instructions.

**STALLATION, DECORATING WOOD FRAMING 1** in. x 4 in. (25 mm x 102 mm) wood furring may be used in non-fire-rated construction for screw application where support member spacing is 24 in. (610 mm) OC maximum. Furring of 2 in. (51 mm) nominal thickness should be used in non-fire-rated construction for nail application of board or where framing spacing is from 24 in. (610 mm) to 48 in. (1219 mm) OC maximum.

Installation of grillage should be the same as for single-layer drywall application. Refer to USG Drywall Suspension System Brochure (AC3152) or contact the Steel Stud Manufacturers Association for application information.

At the perimeter and vertical penetrations, the exposed core of panels must be covered with a J-stop trim or securely fastened moldings. In areas subject to freezing temperatures and other severe weather conditions, shingled roofs should be installed in accordance with good roofing practices. Fascia boards should extend at least 1/4 in. (6.4 mm) below the ceiling board or adjacent trim moldings, whichever is lower, to provide a drip edge.

Where ceiling board expanse exceeds 4 ft. (1219 mm), a space of at least 1/4 in. (6.4 mm) should be provided between edge of ceiling board and adjacent walls, beams, columns and fascia. This space may be screened or covered with molding but should not be caulked.

USG Sheetrock<sup>®</sup> Brand Mold Tough<sup>®</sup> Panels Firecode<sup>®</sup> X, like other building materials, is subject to structural movement, expansion and contraction due to changes in temperature and humidity.

This ASTM lab test may not accurately represent the mold performance of building materials in actual use. Given unsuitable project conditions during storage, installation or after completion, any building material can be overwhelmed by mold.
